

Scholarship Guidelines

The Scholarship guidelines are listed here for prospective recipients to review prior to completing an application form.

Eligibility:

Each candidate for the award must be

1. A resident of Lambton County for a period of at least one year.
2. Eligible to enroll in a college recognized by the Association of Universities and Colleges as recognized and funded by the respective provincial government with the intent of pursuing a career in the trades or other college certification.
3. A Canadian Citizen or landed immigrant
4. Have significant financial need as demonstrated by the application document.
5. Students attending a secondary school, college or adult education centre will be eligible. In exceptional circumstances students making direct application to the Foundation through the advertised application process who meet the criteria may be considered.

Conditions:

1. Candidates may be required to present bank statements and income tax returns in support of their application.
2. Preference will be given to those candidates that meet the conditions established by the Society of St Vincent de Paul, Sarnia/Lambton Particular Council
3. The award is given to an individual who has the desire and ability to attend a college offering trades education or college level certification. Personal financial circumstances will be a determining factor in the final decision but the individual must also be able to meet the academic standards required for enrollment in a post-secondary institution.
4. The award will be made once confirmation of enrollment is received. The award may be renewable subject to satisfactory performance and reapplication. Should the individual receive additional scholarships or financial assistance the value of the renewal may be decreased.

Scholarships are awarded on the understanding that the funds will be used to cover the cost of attending a programme of studies and may be directed to the academic institution. Currently, the scholarship is valued at \$1000.00

Application Process:

1. All applicants are required to complete in full the scholarship application form and include all the required documents as listed. The completed application and supporting documents must be sent or delivered to:

2. Applications must be received in the Foundation office by **4 pm MARCH 31st** of any year. If March 31st is a weekend day the deadline is extended to the next business day. Late applications will not be considered.
3. A letter or email acknowledging the receipt of the application will be sent.

4. All applications that include the requested material and that meet the eligibility requirements as outlined above are forwarded for consideration to the Scholarship Committee.
5. A meeting with the Scholarship committee may be required.
6. Successful applicants are notified as soon as possible after the decision is made by phone or email with a follow up letter send to their home address.
7. Those applicants that are declined are informed in writing. The decision of the Committee is final.
8. The award will be made by cheque to the recipient or the academic institution as determined by the recipient.

These must be written on your behalf by someone other than a family member or relative. One should be from an individual qualified to speak on your academic potential. The second should be from someone who has knowledge of your challenge and how you have managed your studies in conjunction with the challenges you face.

[] Information about your academic performance

This should include an official transcript issued by your high school, proof of graduation, or proof of equivalent academic standing for mature students. Students anticipating graduation after the deadline should submit a copy of their latest report card and a Grade 11 transcript.

Please Note:

Should you be selected as the scholarship recipient you will be required to provide the Foundation with your full legal name, date of birth and your Social Insurance Number .This information is required for audit purposes at the Foundation and will only be used as required by the distribution of scholarship funds. This must be received prior to the funds being released.
