

General Information:

Grants made through the Petrolia Community Fund range in value between 200 and 2000 dollars. Requests for larger amounts may be considered by the Committee and the Fund Administrator but will require additional documentation and may be directed to the Sarnia Community Foundation's Community Impact Grant Process. Projects funded *must impact the Petrolia area directly*. Grants are made on a one-time basis. Previous funding does not guarantee additional funds will be granted for the same project or programme in subsequent years.

The application must be submitted in both electronic (pdf) and paper format by November 30th, 2024 at 4 pm as follows:

The pdf file application must be sent to <u>office@sarniacommunityfoundation.ca</u> and reach the Office and Grants Administrator by the time deadline on November 30th

and

ONE Paper copy must be delivered to the Fund Administrator (Sarnia Community Foundation)*

*The *paper* application may be delivered to the Town of Petrolia office BUT must be received by the 29th of November at 4 pm in that location to ensure delivery by the posted deadline to the Fund Administrator. Envelopes must be sealed and clearly marked to the attention of the Petrolia Community Fund Grant Administrator.

Town staff are NOT involved in the selection process and will not accept emailed submissions.

The following are NOT eligible for micro grants.

- Annual Fund drives
- Travel costs
- Building campaigns

- Debt reduction Political activities
- Endowment funds
- Direct religious activities
- Projects, programs or expenses that will be completed or incurred before December 15th, 2025.

GRANTS will be awarded in January 2025 at the Petrolia City Council meeting.

Applicants chosen to receive a grant must:

- Provide any documentation required by the Fund Administrator to prove the grant funds were allocated to the project applied for (e.g. receipts, minutes, bank statement etc.)
- Be available for photos, interviews or any other promotional activities as arranged by the Foundation (e.g. banquets, award ceremonies, media interviews, etc.) This may include speaking to the grant impact in a short video.
- Acknowledge the Petrolia Community Fund as a funder during the fiscal year in which they receive the grant

By signing the application, the applicant agrees to comply with the expectations of grant recipients detailed in this application and gives The Fund permission to publish grant, agency information including names related to the grant.

Grant applications, which are not approved, will remain confidential.

The Petrolia Community Fund is administered by the Sarnia Community Foundation.
